ASSESSMENT CRITERIA		
Council has set out the objective and decision guidelines that the municipal buildin surveyor will exercise when considering varying a design and siting standard for fencing.		
Note: If any matter set out in the guideline is not met, then Council <u>must refuse</u> consent.		
Objective: To ensure buildings do not unreasonably overshadow existing secluded privat open spaces.		
Decision Guidelines: The reporting authority may give its consent where a fence doe not comply with regulation 96 of the Building Regulations 2018 (as ratified by Council), if -		
(a) The proposed fence will not significantly impact on the amenity of the secluded privat open space(s) on nearby allotments; and
