

## Spot A Whale Competition Full Terms and Conditions

1. The promoter is Glenelg Shire Council, ABN, of 48 217 289 490, with the prizemoney.
2. Submission of an entry into the promotion is deemed acceptance of these Terms.
3. Glenelg Shire Council may, in its discretion, refuse to award any prize to any entrant who fails to comply with these terms.
4. Entry is only open to Victorian residents aged 16 years and older.
5. Entrants aged between 16 and up to but not including 18 years of age must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms.
6. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
7. Employees of the Glenelg Shire Council's Senior Executive Team and Economic Development Department teams are ineligible.

10. Entrants must event via Instagram. Capture an image of a whale and post the image from their personal account, ensuring the post is open to public (not set to private) and tag Visit Glenelg Vic and Glenelg Shire Council.

The media team will select a winner based on photograph creativity and capturing not seen before shots and consideration of additional entry by those who download the app. The winner of the weekly prize will be notified via Instagram by 5pm every Wednesday. The winners will be requested for a copy of the image to use for the announcement to be posted on the Glenelg Shire social media pages.
12. There will be a weekly prize of \$200 in the form of a Shop Local gift voucher (Portland residents) or gift voucher for a local Glenelg Shire business of the recipient's choice if located elsewhere.
13. The prizes must be claimed within 21 days of winners being notified, unless otherwise stated in these terms and conditions. All unclaimed prizes are the property of Glenelg Shire Council.
