**ASSESSMENT CRITERIA**

The Minister for Planning in his Minister’s Guideline (MG/12) has set out the objective and decision guidelines that Council must have in regard to when considering varying a design and siting standard.

Note: If any matter set out in the guideline is not met, then Council **must refuse** consent.

**Objective:** To ensure that the setbacks of buildings from a street respect the existing or preferred character of the neighbourhood and make efficient use of the site.

**Decision Guidelines:** The reporting authority may give its consent where a single dwelling, does not comply with Regulation 74 of the Building Regulations 2018, if -
